

1 **IT IS HEREBY ORDERED, ADJUDGED AND DECREED** that Plaintiffs, TRUSTEES OF
2 THE BRICKLAYERS & ALLIED CRAFTWORKERS LOCAL 13 DEFINED CONTRIBUTION
3 PENSION TRUST FOR SOUTHERN NEVADA, TRUSTEES OF THE BRICKLAYERS & ALLIED
4 CRAFTWORKERS LOCAL 13 HEALTH BENEFITS FUND, TRUSTEES OF THE BRICKLAYERS
5 & ALLIED CRAFTWORKERS LOCAL 13 VACATION FUND; BRICKLAYERS & ALLIED
6 CRAFTWORKERS LOCAL 13 NEVADA; TRUSTEES OF THE BRICKLAYERS & TROWEL
7 TRADES INTERNATIONAL PENSION FUND; TRUSTEES OF THE BRICKLAYERS & TROWEL
8 TRADES INTERNATIONAL HEALTH FUND; and TRUSTEES OF THE INTERNATIONAL
9 MASONRY INSTITUTE, shall recover from Defendants, Marbella Flooring, Inc. and Robert Olmos,
