1 I, JAMES D. BOYLE, ESQ., under penalty of perjury pursuant to the laws of the United
2 States, hereby state as follows:

3 1. I am one of the attorneys for Plaintiff Caesars World, Inc. ("Caesars") in the
4 above-captioned action. I am a partner with the law firm of Santoro, Driggs, Walch, Kearney,
5 Holley & Thompson ("SDW"). SDW is designated local counsel for Caesars in the above-
6 captioned action.

7 2. I make this Affidavit in Support of Caesars's Memorandum of Fees and Costs
8 (the "Memorandum") filed herewith. I am over the age of eighteen years and I am competent to
9 testify herein. I have personal knowledge of the facts set forth herein, and could and would
10 testify to the same if called to do so.

11 3. On December 19, 2011, this Court entered a Minute Order (Docket No. 49) (the
12 "December 19th Order"). Among other things, the December 19th Order awarded Caesars its
13 reasonable attorneys' fees incurred in attempting to obtain discovery from Defendants Marcel
14 July and Octavius Tower LLC (collectively "Defendants"), and in prosecuting its Motion to
15 Compel Defendants to Respond to Caesars' First Set of Interrogatories and Document Requests
16 (the "Motion to Compel") (Docket No. 42), pursuant to Fed. R. Civ. P. 37(a)(5).

17 4. I graduated from Willamette University College of Law in May 1997, and was
18 admitted to the State Bar of Washington in October 1997 and to the State Bar of Nevada in
19 October 2003. My practice has focused nearly exclusively in commercial litigation, including in
20 the areas of intellectual property, corporate finance and business relations, pharmaceuticals, and
21 gaming. My current billing rate for this matter as designated local counsel is \$225.00 per hour.

22 5. In addition to the work I have completed in this matter, SDW utilized the services
23 of Ms. Joy Jones. Ms. Jones has over seven (7) years of paralegal experience, primarily in the
24 practice of federal litigation and intellectual property. Ms. Jones's billing rate in this matter is
25 \$125.00 per hour.

26 6. SDW has engaged in considerable research related to determining that the hourly
27 fee rates charged by its attorneys and paralegals, including those fees charged by me and Ms.
28 Jones, are reasonable and fair within the market encompassing Clark County, Nevada. The



1 research conducted by my firm includes, without limitation, surveys of law firms of comparable
2 size and experience related to the legal issues confronted by SDW's clients. In addition, SDW
3 factors in data collected and made public by the State Bar of Nevada related to the billing rates of
4 comparable law firms.

5 7. Attached hereto and incorporated herein by this reference as **Exhibit A-1** is an
6 itemized Transactions Listing for the period October 1, 2011 to November 7, 2011, indicating
7 the total time and amount billed by me and Ms. Jones for that time period related to attempts to
8 obtain discovery from Defendants. The report has been reviewed and edited to reflect only those
9 fees that relate to such attempts.

10 8. To date, I have billed Caesars for 1.0 hour of work, for an aggregate of fees billed
11 totaling \$225.00, related to attempts to obtain discovery from Defendants.

12 9. To date, Ms. Jones has billed Caesars for 1.90 hours of work, for an aggregate of
13 fees billed totaling \$237.50, related to attempts to obtain discovery from Defendants.

14 10. To date, Caesars has incurred costs in the amount of \$6.40 related to attempts to
15 obtain discovery from Defendants.

16 11. Attached hereto and incorporated herein by this reference as **Exhibit A-2** is an
17 itemized Transactions Listing for the period October 1, 2011 to November 7, 2011, indicating
18 the total costs billed by SDW for that time period related to attempts to obtain discovery from
19 Defendants. The report has been reviewed and edited to reflect only those costs that relate to
20 such attempts.

21 12. Attached hereto and incorporated herein by this reference as **Exhibit A-3** is an
22 itemized Transactions Listing for the period November 8, 2011 to December 28, 2011, indicating
23 the total time and amount billed by me and Ms. Jones for that time period related to preparing
24 and prosecuting the Motion to Compel. The report has been reviewed and edited to reflect only
25 those fees that relate to the Motion to Compel.

26 13. To date, I have billed Caesars for 8.8 hours of work, for an aggregate of fees
27 billed totaling \$1,980.00, related to preparing and prosecuting the Motion to Compel.
