1 THIS MATTER having come before the Court pursuant to Plaintiff Caesars World, Inc.'s
2 Memorandum of Fees and Costs (the "Memorandum"), and pursuant to this Court's Order dated
3 December 19, 2011 (Docket No. 49), the Court having reviewed the Memorandum, and the
4 supporting affidavits and exhibits attached thereto, it is hereby ORDERED and DECREED as
5 follows:

6 1. Judgment is hereby entered against Defendants Marcel July and Octavius Tower
7 LLC (collectively "Defendants"), jointly and severally, and in favor of Plaintiff
8 Caesars World, Inc. ("Caesars") for attorneys' fees and costs incurred in
9 attempting to obtain discovery from Defendants and for prosecuting the Motion to
10 Compel Discovery from Defendants and supporting documents and materials
11 (collectively, the "Motion to Compel") pursuant to Fed. R. Civ. P. 37(a)(5) as
12 follows:

- 13 a. Caesars is hereby awarded its reasonable attorneys' fees for attempting to
14 obtain discovery from Defendants in the amount of two thousand eight
15 hundred three dollars (\$2,803.00); and
- 16 b. Caesars is further awarded its costs for attempting to obtain discovery from
17 Defendants in the amount of six dollars and forty cents (\$6.40); and
- 18 c. Caesars is hereby awarded its reasonable attorneys' fees for prosecuting the
19 Motion to Compel in the amount of eighteen thousand three hundred thirty
20 dollars and fifty cents (\$18,330.50); and
- 21 d. Caesars is further awarded its costs for prosecuting the Motion to Compel in
22 the amount of forty one dollars and ten cents (\$41.10).
- 23 e. Caesars is hereby awarded its reasonable attorneys' fees and costs for
24 preparing and filing its Memorandum of Fees and Costs in the amount of two
25 thousand six hundred nineteen dollars and thirty cents (\$2,619.30).
