26 **JOINT STIPULATION OF DISMISSAL WITH PREJUDICE**

27 In accordance with a confidential settlement agreement between the parties, and pursuant  
 28 to Fed. R. Civ. P. 41(a)(1) and 41(c), it is hereby STIPULATED AND AGREED that all claims

1 in this action are hereby dismissed with prejudice. This dismissal includes claims that Marcel  
2 July has committed fraud on the U.S. Patent and Trademark Office. After receiving information  
3 during discovery, Caesars believes that its claim that Marcel July committed fraud on the U.S.  
4 Patent and Trademark Office was incorrect and dismisses the claim with prejudice. Each party


