**ORDER GRANTING MOTION TO
 DISMISS FILED BY DEFENDANT
 LITTON LOAN SERVICING LP**


18 Defendant Litton Loan Servicing LP (“Litton”) filed a Motion to Dismiss Plaintiffs’ First
 19 Amended Complaint and Motion to Expunge Lis Pendens on July 7, 2011. See Docket No. 69.
 20 Pursuant to Local Rule 7-2(b) of the United States District Court for the District of Nevada,
 21 Plaintiffs’ Opposition was due on or before July 22, 2011. Plaintiffs have not filed any response
 22 or opposition to Litton’s Motion to Dismiss Plaintiffs’ First Amended Complaint and Motion to
 23 Expunge Lis Pendens. Pursuant to Local Rule 7-2(d), “[t]he failure of an opposing party to file
 24 points and authorities in response to any motion shall constitute a consent to the granting of the
 25 motion.”

1 IT IS THEREFORE ORDERED that based on the Plaintiffs failure to file points and
2 authorities in opposition to Litton's Motion to Dismiss and the arguments set forth in Litton's
3 Motion to Dismiss, Litton's Motion to Dismiss is GRANTED and all claims asserted against
4 Litton in Plaintiffs' First Amended Complaint are hereby dismissed with prejudice.

5 IT IS FURTHER ORDERED that any notice of lis pendens or similar document affecting
6 the property located at 1623 Graystone Canyon Avenue, Las Vegas, Nevada 89123 (APN 177-26-
7 110-056) and recorded by Plaintiffs in the public records of Clark County, Nevada is hereby
8 expunged and shall have no further force or effect.
