JUDGMENT

23 This Court issued its Order granting summary judgment in favor of Plaintiffs, the Board of
 24 Trustees, in their capacities as Trustees of the Construction Industry and Laborers Health and
 25 Welfare Trust; Trustees of the Construction Industry and Laborers Joint Pension Trust; Trustees
 26 of the Construction Industry and Laborers Vacation Trust; and Trustees of the Southern Nevada
 27 Laborers Local 872 Training Trust (“Plaintiffs”), and against Defendant Road and Highway
 28 Builders, LLC (“Defendant”), which was signed by the Honorable James C. Mahan on November


1 19, 2012, and filed with the Court on November 19, 2012. A copy of the Court's Order is
2 attached as Exhibit A.

3 Having considered the pleadings and arguments in this matter, and good cause appearing,
4 **JUDGMENT IS HEREBY ENTERED AS FOLLOWS:**

5 Plaintiffs' Motion for Summary Judgment is granted in its entirety. Defendant Road and
6 Highway Builders, LLC is ordered to pay to Plaintiffs:

- 7 1. Delinquent contributions of \$166,946.34;
- 8 2. Interest on the delinquent contributions at a rate of fourteen percent (14%) per
9 annum from the due date until the date of judgment of \$87,489.22;
- 10 3. Liquidated damages in an amount equal to the interest due of \$87,489.22;
- 11 4. Audit fees of \$2,435.19; and
- 12 5. Attorneys' fees of \$27,420.00 and costs of \$1,068.15.
