 15 Before the Court is a Motion for Default Judgment filed in this case by Plaintiff, HICA
 16 Education Loan Corporation (“Plaintiff”), against Defendant, Jerry T. Henry (“Defendant”).
 17 The Court takes notice of the entry of Defendant’s Default. (ECF # 10). In consideration of
 18 the Clerk’s records, the pleadings, and the Plaintiff’s Motion, the Court finds that the Plaintiff’s
 19 Motion is in good order and well-founded and that the Plaintiff’s Motion should be
GRANTED. IT IS, THEREFORE,

20 **ORDERED, ADJUDGED, and DECREED** that Plaintiff shall be, and hereby is,
 21 awarded judgment from and against Defendant for **\$44,465.71**, with additional prejudgment
 22 interest from April 24, 2012, to the date of this judgment at the rate of \$3.76 per day.

23 **IT IS FURTHER ORDERED, ADJUDGED, and DECREED** that this judgment
 shall bear interest from the date of this judgment until it is paid at a variable rate calculated by

1 the Secretary of the Department of Health and Human Services for each calendar quarter and
