I. PURPOSE OF THE STUDY

The purpose of this study is to determine whether the appearance of the Nike Air Force 1 sneaker functions as a source identifier. Specifically, the study is designed to assess whether relevant consumers associate the appearance of the Nike Air Force 1 sneaker with a single sneaker brand or source and in particular, Nike.

II. HOW THE STUDY WAS CONDUCTED

Face-to-face interviews were conducted in each of the nine census divisions, thus providing a cross-section of individuals across the United States.

Included in the study are responses from 325 individuals interviewed between November 29, 2007, and January 22, 2008.

A. The Survey Universe

Qualified respondents were defined as individuals:

- 1. Ages fifteen to thirty-four;
- 2. who, within the past 6 months, had purchased or someone else had purchased for them (or within the next 6 months were likely to purchase or have someone else purchase for them) any sneakers, not just for use for athletic activities, but for other things such as wearing for style¹;
- who were not, and had no other family member, employed by a marketing research firm, advertising agency, sales promotion firm, public relations firm or a company that makes or sells any footwear;
- 4. who had not participated in a marketing research survey other than a political poll in the past thirty days, and
- 5. who had eye glasses or contact lenses with them for the interview, if they normally wear eye glasses or contact lenses when shopping.

Two hundred seventy-nine (279) or 85.8% of the respondents purchased or someone purchased for them in the past 6 months, 308 or 94.8% said they were likely to purchase or have someone purchase for them in the next 6 months, and 262 or 80.6% both purchased or had someone purchase for them in the past and said they were likely to purchase or have someone purchase for them in the future.

B. Sample Frame and Composition

Individuals were approached in shopping malls and asked screening questions to determine their eligibility. If the potential respondent met the screening criteria and agreed to participate in the study, he/she was asked to accompany an interviewer to a private office to complete the interview.

Approximately one-third (36%) of the U.S. population resides in the South, and about one-fifth (18% to 23%) resides in each of the other three regions (i.e., the North, the Midwest, and the West). Geographic quotas were established to reflect these relative distributions. (See Appendix, page 12 for the distribution of completed interviews.)

C. Sneakers Studied

The questionnaire was administered to respondents randomly assigned to either a test group or a control group.

Respondents in the test group were questioned about the Nike Air Force 1 sneaker, the test stimulus. For the control group, respondents were questioned about the Adidas Superstar II sneaker, the control stimulus. For both the test and control stimulus, all names and any identifying logos were removed.

The purpose of a control group is to estimate the level of survey "noise" that results from causes other than the element (appearance of the sneaker) at issue, i.e., responses resulting from simply guessing or misunderstanding the questions asked. The primary method of estimating the level of survey "noise" is to ask the same questions with a control.

In this study, the level of survey "noise" is estimated from the proportion of respondents who associate the appearance of the Adidas sneaker with Nike as a single source. This proportion is then subtracted from the proportion of appearance-related Nike single source responses given by those individuals

asked about the Nike sneaker, in order to derive an estimate of association free from survey "noise." In other words, the control ensures that we count as a Nike single source response only those respondents whose association was indeed caused by the appearance of the Nike sneaker and not other unrelated factors.

D. The Respondent Task and Questionnaire

To discourage guessing, respondents were first told: "For each of my questions, if you don't know or don't have an answer, please don't guess. Just tell me you don't know or don't have an answer and we'll go on to the next guestion."

Respondents were then shown six photographs of a sneaker showing the front and back, both sides and the top and bottom.

Respondents were then asked:

"Do you associate the sneaker shown in these photographs with any particular brand name or brand names of sneakers?" (Question 1)

Respondents who said "Yes" to Question 1 were asked:

"With what sneaker brand name or brand names do you associate the sneaker shown in the photographs"? (Question 2)

Respondents who gave a brand name or names were asked:

"What makes you associate this sneaker with (name given)?" "Anything else?" (Questions 3a-5b)

Respondents who said "Don't Know," to Question 2 were asked.

"Do you associate the sneaker shown in the photographs with one brand of sneakers or with more than one brand of sneakers?" (Question 6) (Questionnaire Versions 1 and 3)

"Do you associate the sneaker shown in the photographs with more than one brand of sneakers of with one brand of sneakers?" (Question 6) (Questionnaire Versions 2 and 4) As shown above, the order of asking "one company" or "more than one company" was rotated from one respondent to another to eliminate systematic bias being introduced as a function of whether the respondent heard "one" or "more than one brand" first.

Finally, a respondent's name and telephone number were requested.

E. <u>Development of the Questionnaire</u>

Mr. Mantis developed the Consumer Study Screener, the Questionnaire and Interviewer Instructions.

F. Interview Validation

Survey protocols require that a portion of all interviews be validated. Respondent names and phone numbers were provided to an independent telephone interviewing agency. Of the 325 respondents interviewed, 141 or 43.4% were contacted, all confirming their participation in the study.²

G. <u>Double-Blind Interviewing</u>

The survey was administered under double-blind conditions: neither the interviewers nor the respondents were informed of the purpose or sponsor of the survey.

H. Coding and Tabulation of Data

Mr. Mantis coded and tabulated the responses.

This proportion far exceeds the industry norm of 15% validation.

I. Appendix

Appended to this report are the consumer study screener, interviewer instructions, questionnaire, sample composition, interviewing locations, validation questionnaire and report, my qualifications, cases in which I have testified in the past four years, compensation, and photographs of the sneakers studied.

III. FINDINGS

The study is designed to assess distinctiveness of a trademark which is measured by association of that trademark with a single source. Thus, any conclusion regarding distinctiveness will be based on those respondents who associate the Nike Air Force 1 sneaker with one source and only one source of sneakers and in particular, Nike.

Shown on TABLE 1 (page 11) are the responses to Question 1. Of the 217 test group respondents, 170 or 78.3% answered in the affirmative indicating that they associate the Nike Air Force 1 sneaker with a particular brand name or brand names of sneakers.

Question 2 was asked of only those individuals who said "Yes" in response to Question 1. As shown on TABLE 2 (pages 12-14), 149 or 68.7% of all test group respondents associate the Nike Air Force 1 sneaker with a single source. The vast majority of these respondents (123) mentioned Nike and only Nike. Additionally, six (6) respondents gave qualified responses indicating that they may associate the Air Force 1 sneaker with Nike.

Eight (8) control group respondents associate the Adidas Superstar II sneaker with Nike and only Nike as the single source.

While not counted as responses indicating trademark distinctiveness, it is of interest to note that of the test group respondents who associate the Nike Air Force 1 sneaker with more than one brand, 14 identify Nike as one of the brands.

Shown on TABLE 3 (page 15) are the responses to Question 6. Of the two (2) control group respondents who did not know the brand or brands in response to Question 2, one (1) respondent associates the Adidas Superstar II sneaker with a single though unspecified brand and one (1) respondent associates it with more than one brand.

Respondents were asked to explain their answers to Question 2, thus providing a basis to understand why they associate the Air Force 1 sneaker with Nike. Shown on TABLE 4 (pages 16-35) are the verbatim responses for the 123 respondents who associate the Air Force 1 sneaker with Nike and only Nike. Virtually all of these respondents (120) cited the appearance of the Air Force 1 sneaker as the basis for association with Nike.

Shown on TABLE 5 (pages 36-37) are the verbatim responses for the six (6) respondents who may associate the Air Force 1 sneaker with Nike.

Shown on TABLE 6 (pages 38-41) are the verbatim responses for the 20 respondents who associate the Air Force 1 sneaker with a single source other than Nike.

Shown on TABLE 7 (pages 42-45) are the verbatim responses for the 14 respondents who associate the Air Force 1 sneaker with Nike and another source.

Shown on TABLE 8 (pages 46-47) are the verbatim responses for the five (5) respondents who associate the Air Force 1 sneaker with more than one source other than Nike.

Shown on TABLE 9 (page 48) are the verbatim responses for the two (2) respondents who do not associate the Air Force 1 sneaker with Nike but said it looks like Nike.

Shown on TALBE 10 (pages 49-50) are the verbatim responses for the eight respondents (8) who associate the Adidas Superstar II sneaker with Nike and only Nike.

Shown on TABLE 11 (pages 51-62) are the verbatim responses for the 72 respondents who associate the Adidas Superstar II sneaker with a single source other than Nike.

Shown on TABLE 12 (page 63) are the verbatim responses for the two (2) respondents who associate the Adidas Superstar II sneaker with Nike and another source.

Shown on TABLE 13 (pages 64-66) are the verbatim responses for the eight (8) respondents who associate the Adidas Superstar II sneaker with more than one source other than Nike.

Shown on TABLE 14 (page 67) are the verbatim responses for the two (2) respondents who associate the Adidas Superstar II sneaker with an unspecified source.

Shown below is a summary of association responses. Total association (unadjusted for survey "noise") accounts for 120 or 55.3% of the 217 test group respondents. These respondents associate the Nike Air Force 1 sneaker with Nike and only Nike and do so for appearance-related reasons.

The level of survey "noise" is estimated from the proportion of control group respondents (6.5%) who associate the appearance of the Adidas Superstar II sneaker with Nike and only Nike. Adjusting for survey "noise" yields a net association of 48.8%.

IV. CONCLUSION

Based on my education, experience and the results of this rigorous test-control, double-blind study, it is my opinion that the appearance of the Nike Air Force 1 sneaker functions as a source identifier.

An appreciable proportion of purchasers and users of sneakers, almost one-half of all individuals interviewed, associate the appearance of the Nike Air Force 1 sneaker with one brand of sneakers, specifically Nike.
