The Tucker Defendants request expedited consideration of their motion to preserve Mr. Tucker's Sixth Amendment rights and to secure the release of advance deposit funds or permission to release a reasonable flat fee so that criminal defense counsel can defend the complex criminal case pending in the Southern District of New York.
- 2. The parties jointly request that the Court expedite consideration of those motions, and agree to the following briefing schedule. Responding memoranda shall be filed by May 3, 2016, and reply memoranda shall be filed by May 9, 2016.
