5 interpleading the proceeds of the contractors license bonds that are at issue in this case.
6 Accordingly, the Trust Funds and Great American have filed a Stipulation and Order for
7 Dismissal of Great American simultaneously with this Joint Motion.

8 There are no remaining issues to be resolved in this matter. Therefore, the Parties
9 respectfully request that the Court vacate the scheduled Status Conference.
