 23 determined that this Order should issue pursuant thereto and it appearing to the Court, after due  
 24 deliberation, that Defendant is actually engaged in committing and will continue to commit acts  
 25 of copyright infringement through its sale or offer for sale, promotion, and marketing of products  
 26 that infringe on any of Plaintiffs United States copyright registrations, including but not limited  
 27 to works protected by United States Copyright Registration Nos. VA-1-425-762, VAu-1-002-

12 1-668-335, VA-1-668-337, VA-1-747-291, VA 1-684-990, VAu 1-036-279, VA 1-341-698, VA  
13 1-370-959, VA 1-370-956, VA 1-370-955, VA 1-370-957, VA 1-425-753, VA 1-670-212, VAu  
14 967-187, VA 1-667-902, VA 1-671-412, VA 1-670-132, VA 1-775-716;


