5 **IT IS FURTHER ORDERED** that the Nevada Department of Corrections through the  
6 Warden of the Southern Desert Correctional Center, or his designee, shall provide a full and  
7 complete hard copy of the records produced in compliance with this Order to **SEAN DOUTRE,**  
8 **#60666**, on or before **Wednesday, October 1, 2014 at 10:00 AM**.

9 **IT IS FURTHER ORDERED** that the Defendants in the above-captioned matter shall  
10 provide a copy of this Order to the above-named officials within the Nevada Department of  
11 Corrections, and any other official(s) whose action is required to comply with this Court's Order.
