18 **DEFAULT JUDGMENT OF FORFEITURE AS TO THE 2006 MERCEDES-BENZ ML350**
 19 **VIN NO. 4JGBB86E46A016429, ALL PERSONS AND ENTITIES LISTED IN EXHIBIT 1,**
 20 **AND ALL PERSONS OR ENTITIES WHO CLAIM AN INTEREST IN THE 2006**
 21 **MERCEDES-BENZ ML350 VIN NO. 4JGBB86E46A016429**

21 **I. FACTS**

22 1. From 2008 to 2011, Eduard Petroiu, Vladimir Budestean, Delyana Nedyalkova, and
 23 others were engaged in a massive fraud where the conspirators would offer cars, trucks and other
 24 conveyances for sale over the internet that did not exist or did not belong to the conspirators to sell.
 25 Relying on the schemers' false promises, over 300 unwitting buyer/victims sent money to the
 26 conspirators expecting to receive a car, or similar conveyance, that was never delivered.

1 2. Eduard Petroiu and Aurel Petroiu purchased the 2006 Mercedes-Benz ML350 VIN No.
2 4JGBB86E46A016429 on September 1, 2009, at a Honda Dealership located in Las Vegas, Nevada.
3 The vehicle was titled to both Petroius and registered to Aurel Petroiu.

4 3. During the course of the two and a half year investigation, law enforcement surveilled
5 the 2006 Mercedes-Benz ML350 approximately 160 hours. Of that time period, Eduard Petroiu was
6 seen occupying and operating the 2006 Mercedes-Benz ML350 virtually every time, while Aurel
7 Petroiu was never seen operating the 2006 Mercedes-Benz ML350.

8 4. At all relevant times, Eduard Petroiu was unemployed and lacked the sufficient and
9 legitimate resources to purchase the 2006 Mercedes-Benz ML350.

10 5. Once targeted by law enforcement, Eduard Petroiu and his co-conspirators' fraud
11 scheme came to a swift end, culminating in their indictment in December 2011. A superseding
12 indictment was returned against the defendants in October 2012. Eduard Petroiu was sentenced on
13 March 24, 2014, to Conspiracy to Commit Wire Fraud. All but two of the 17 conspirators have pled
14 guilty and have been sentenced.

15 **II. PROCEDURE**

16 6. The United States filed a verified Complaint for Forfeiture in Rem on May 24, 2012.
17 Complaint, ECF No. 1. The Complaint (ECF No. 1) alleges the defendant property:

- 18 a. constitutes or is derived from proceeds traceable to violations of 18 U.S.C. §
19 1343, a specified unlawful activity as defined in 18 U.S.C. §§ 1956(c)(7)(A)
20 and 1961(1)(B), or a conspiracy to commit such offenses and is, therefore,
21 subject to seizure pursuant to 18 U.S.C. § 981(b), and forfeiture pursuant to 18
22 U.S.C. § 981(a)(1)(C); and
- 23 b. is involved in transactions or attempted transactions in violation of 18 U.S.C. §
24 1956, or is a property traceable to such properties, and is, therefore, subject to
25 seizure pursuant to 18 U.S.C. § 981(b), and forfeiture pursuant to 18 U.S.C. §
26 981(a)(1)(A).

1 7. On June 5, 2012, the Court entered an Order for Summons and Warrant of Arrest in
2 Rem for the Property and Notice and issued the Summons and Warrant of Arrest in Rem. Order for
3 Summons and Warrant, ECF No. 4; Summons and Warrant, ECF No. 5.

4 8. Pursuant to the Order (ECF No. 4), the Complaint (ECF No. 1), the Order (ECF No. 4),
5 the Summons and Warrant (ECF No. 5), and the Notice of Complaint for Forfeiture (ECF No. 6, p. 3-
6 4, 20-21; ECF No. 9, p. 4-5, 21-22, 38-39, 55-56, 72-73, 89-90; ECF No. 10, p. 3-4; ECF No. 21-1, p.
7 1-3; ECF No. 22-1, p. 1-4; ECF No. 24, p. 3-4) were served on the 2006 Mercedes-Benz ML350 VIN
8 No. 4JGBB86E46A016429 and all persons claiming an interest in the 2006 Mercedes-Benz ML350
9 VIN No. 4JGBB86E46A016429. Notice was published according to law.

10 9. Pursuant to Supplemental Rules for Admiralty or Maritime Claims and Asset Forfeiture
11 Actions (“Fed. R. Civ. P. Supp. Rule”) G(5), all persons interested in the defendant property were
12 required to: (1) file a verified claim, setting forth the person’s or its interest in the property, that (a)
13 identifies the specific interest in the property claimed, (b) identifies the claimant and states the
14 claimant’s interest in the property, and (c) is signed by the claimant under penalty of perjury pursuant
15 to 28 U.S.C. § 1746; (2) file the verified claim with the Clerk of the above-entitled Court no later than
16 35 days after the notice is sent or, if direct notice was not sent, no later than 60 days after the first day
17 of publication on the official internet government forfeiture site, www.forfeiture.gov; (3) file an
18 answer to the Complaint for Forfeiture in Rem or a motion under Rule 12 with the Clerk of the Court,
19 Lloyd D. George United States Courthouse, 333 Las Vegas Boulevard South, Las Vegas, NV 89101,
20 no later than 21 days after filing the verified claim; and (4) serve a copy of the verified claim and the
21 answer at the time of each filing on Michael A. Humphreys, Assistant United States Attorney, Lloyd
22 D. George United States Courthouse, 333 Las Vegas Boulevard South, Suite 5000, Las Vegas, Nevada
23 89101. Complaint, ECF No. 1; Order for Summons and Warrant, ECF No. 4; Summons and Warrant,

10 **III. JUDGMENT**

11 349. Pursuant to Fed. R. Civ. P. 54(c) and 55(b), the judgment by default does not “differ in
12 kind from, or exceed [the] amount” of relief listed in the complaint for forfeiture.

13 **IV. DEFAULT AND ENTRY OF DEFAULT**

14 350. As shown above, the United States has requested entry of Clerk’s Default against: (1)
15 the 2006 Mercedes-Benz ML350 VIN No. 4JGBB86E46A016429; (2) all persons and entities listed in
16 Exhibit 1; and (3) all persons or entities who claim an interest in the 2006 Mercedes-Benz ML350 VIN
17 No. 4JGBB86E46A016429 in the above-entitled action (ECF No. 28). The Clerk entered the Default
18 as requested (ECF No. 29).

19 **V. NOTICE**

20 351. Pursuant to Fed. R. Civ. P. Supp. Rule G(4)(a)(iv)(C), the United States published
21 notice via the official internet government forfeiture site, www.forfeiture.gov, for thirty consecutive
22 days. See above. Pursuant to Fed. R. Civ. P. Supp. Rule G(4)(b), the United States served the
23 Complaint, the Order for Summons and Warrant of Arrest in Rem for the Property and Notice, the
24 Summons and Warrant of Arrest in Rem for the Property, and the Notice of Complaint for Forfeiture
25 and Arrest on all known potential claimants. See above.

26 . . .

1 **VI. LEGAL SUFFICIENCY OF THE COMPLAINT**

2 352. The Complaint filed in this action was verified. The Court has subject matter
3 jurisdiction, in rem jurisdiction over the 2006 Mercedes-Benz ML350 VIN No.
4 4JGBB86E46A016429, and venue. The Complaint described the property with reasonable
5 particularity. The Complaint states where the seizure of the 2006 Mercedes-Benz ML350 VIN No.
6 4JGBB86E46A016429 occurred and its current location. The Complaint identifies the statutes under
7 which the forfeiture action is brought. The Complaint alleges sufficiently detailed facts to support a
8 reasonable belief that the United States will be able to meet its burden proof at trial. See facts above.
9 Complaint, ECF No. 1. Fed. R. Civ. P. Supp. Rule G(2).

10 353. The allegations of the Complaint are sustained by the evidence and are adopted as
11 findings of fact. The Court concludes as a matter of law that the United States is entitled to the relief
12 requested in the Complaint.

13 **VII. POTENTIAL CLAIMANTS**

14 354. Peter J. Vanderheyden and Nannette M. Vanderheyden withdrew their claim and they
15 have no interest in the 2000 Mercedes-Benz CLK 430 VIN No. WDBLJ70G7YF153739.

16 355. Robert and Kay Ostram's Claim was struck and they have no interest in the 2006
17 Mercedes-Benz ML350 VIN No. 4JGBB86E46A016429.

18 356. No other person has filed a claim and the time to file a claim has passed.

19 Based on the foregoing this Court finds that the United States has shown its entitlement to a
20 Default Judgment of Forfeiture as to: (1) the 2006 Mercedes-Benz ML350 VIN No.
21 4JGBB86E46A016429; (2) all persons and entities listed in Exhibit 1; and (3) all persons or entities
22 who claim an interest in the 2006 Mercedes-Benz ML350 VIN No. 4JGBB86E46A016429.

23 NOW, THEREFORE, IT IS HEREBY ORDERED, ADJUDGED, AND DECREED that
24 Default Judgment of Forfeiture is entered against: (1) the 2006 Mercedes-Benz ML350 VIN No.
25 4JGBB86E46A016429; (2) all persons and entities listed in Exhibit 1; and (3) all persons or entities

1 who claim an interest in the 2006 Mercedes-Benz ML350 VIN No. 4JGBB86E46A016429 in the
2 above-entitled action.

3 IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that the 2006 Mercedes-Benz
4 ML350 VIN No. 4JGBB86E46A016429 be, and the same is hereby forfeited to the United States of
5 America, and no right, title, or interest in the property shall exist in any other party.

6 IT IS HEREBY CERTIFIED, pursuant to 28 U.S.C. § 2465(a)(2), that there was reasonable
7 cause for the seizure or arrest of the defendant property.
