22 pursuant to Local Rule 6-1, the parties hereby stipulate, agree, and make joint application to
23 extend the time for Defendant Clark County to file its Response to Plaintiffs' Renewed Motion for
24 Approval of a Collective Action Under the Fair Labor Standards Act of 1938, 29 U.S.C. § 201 et
25 seq. and Motion for an Order Requiring Defendant to Provide Contact Information for the

8 Clark County to file its Response to Plaintiffs' Renewed Motion be extended fourteen (14) days
9 from the current deadline of May 11, 2015 to May 25, 2015.
