No further action need be taken to continue this suit by reason of the last sentence of section 205(g) of the Social Security Act, 42 U.S.C. § 405(g).

1 This is the first continuance sought by the Defendant. Defendant is compelled to request
2 this additional time due to an usually large increase in civil actions brought against the Social
3 Security Administration. This onslaught of cases has caused the agency's response time to be
4 slightly delayed.


5 With the Court's approval, the Defendants will file their response on April 10, 2013.
