13 Pursuant to Rule 12 of the Rules Governing Section 2254 Cases In The United States
 14 District Courts, Rule 6(b)(1)(A) of the Federal Rules of Civil Procedure, LR 6-1, and LR 6-2,
 15 petitioner Ivan Dominguez moves for a 4-day extension of time, up to and including Friday,
 16 February 7, 2014, to file a response to respondents' Motion to Dismiss Petitioner's First-
 17 Amended Petition (CR 34).

18 This is Dominguez's second request for an extension of time to file a response to the
 19 motion to dismiss the first-amended petition. The response is currently due February 3, 2014. If
 20 this unopposed motion is granted, a response will be due Friday, February 7, 2014. *See* FRCP
 21 6(a)(1)(C).

22 Counsel for respondents has no objection to this request for a an extension of time.

23 Reasons for the Extension

24 Counsel for Dominguez was sick for several days last week. He had to file two appellate
 25 briefs in the Ninth Circuit between January 21 and January 31, 2014, and he has another appeal

1 brief that must be filed this Wednesday, February 5, 2014. He has a doctor's appointment
2 tomorrow that will take away from the office and work for most of the day. Nevertheless,
3 counsel has been diligently working on preparing an appropriate response to the motion to
4 dismiss, but there are many issues that must be addressed in the response that are relevant to the
5 arguments made in the motion to dismiss, many of which have required extensive research and
6 analysis. Counsel, however, will get the response filed no later than this Friday, February 7,
7 2014.

8 This motion is unopposed. Counsel for respondents has no objection to the request for
9 more time.

10 Conclusion

11 For these reasons, Dominguez respectfully requests the Court grant this unopposed
12 motion and give him until Friday, February 7, 2014 to file a response to respondents' motion to
13 dismiss the first-amended petition.
