29 Pacific Life Insurance Company ("Pacific Life") moves for an
30 extension of time to respond to plaintiffs' Motion to Remand (#26) up to

1 and including March 5, 2013 pursuant to LR 6-1. This is the second such
2 extension requested by Pacific Life. Plaintiffs' counsel have stated that they
3 do not object to extension of this deadline for all defendants.

4 On November 14, 2012, plaintiffs filed this action in the Eighth
5 Judicial District Court, Clark County, Nevada. On December 4, 2012,
6 Pacific Life removed this action to federal court and all other defendants
7 consented to the removal. Plaintiffs filed a Motion to Remand (#26) on
8 January 2, 2013. The Defendants' respective responses in opposition to that
9 motion were due on or before January 22, 2013. Thereafter, Pacific Life
10 sought an extension of time of two (2) weeks, up to and including February
11 5, 2013, for all Defendants herein to prepare responses to the Plaintiff's
12 Motion to Remand. On January 16, 2013, the Court entered an Order (#35)
13 granting Pacific Life's motion.


14 Since the entry of the Court's January 16, Order (#35) the
15 parties have begun exploring the possibility of an early resolution of this
16 dispute. Pacific Life seeks the instant extension because the parties are
17 working diligently and in good faith to achieve an early resolution, but
18 need additional time in which to fully evaluate this possibility. This
19 request is made in good faith and not for the purpose of undue delay.
20 Therefore, Pacific Life requests that the Court grant the instant
