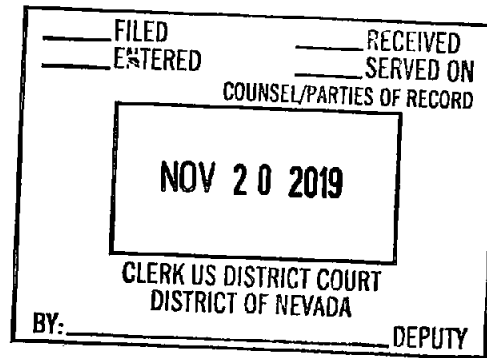

**Amended Order for Summons and Warrant  
 of Arrest in Rem for the Property and  
 Notice**

16 An Amended Complaint for Forfeiture in Rem arising from a federal statute has  
 17 been filed by the United States of America pursuant to Supplemental Rules for Admiralty  
 18 or Maritime Claims and Asset Forfeiture Actions (Fed. R. Civ. P. Supp. Rule) G. The  
 19 Court, having reviewed the Amended Complaint, has found probable cause and that the  
 20 United States has possession of the defendant property; therefore, the clerk shall issue  
 21 Amended Summons and Warrant of Arrest in Rem for the Property, pursuant to Fed. R.  
 22 Civ. P. Supp. Rule G(3)(b).

23 **IT IS HEREBY ORDERED, ADJUDGED, AND DECREED** that an Amended  
 24 Summons and Warrant of Arrest in Rem issue against the following: \$158,677.17 in United  
 25 States Currency, \$761,515.36 in United States Currency, and \$844,586.92 in United States  
 26 Currency (all of which constitute property);

27 **IT IS FURTHER ORDERED, ADJUDGED, AND DECREED** that notice of the  
 28 action and the arrest be given by the United States on the United States' official internet

1 forfeiture site, [www.forfeiture.gov](http://www.forfeiture.gov), for at least 30 consecutive days pursuant to Fed. R. Civ.  
2 P. Supp. Rule G(4)(a)(iv) which is reasonably calculated to notify potential claimants of  
3 this action;

4 **IT IS FURTHER ORDERED, ADJUDGED, AND DECREED** that a copy of  
5 the Amended Complaint for Forfeiture In Rem, this Order, the Amended Summons and  
6 Warrant of Arrest in Rem for the Property, and the Notice of Amended Complaint for  
7 Forfeiture and Arrest be personally served or sent by certified mail, return receipt  
8 requested, and regular mail to any person who reasonably appears to be a potential  
9 claimant on facts known to the United States before the end of the 60 day publication  
10 period which is reasonably calculated to notify potential claimants of this action;

11 **IT IS FURTHER ORDERED, ADJUDGED, AND DECREED** that the United  
12 States shall file proof of publication and service with the Clerk of this Court;

13 **IT IS FURTHER ORDERED, ADJUDGED, AND DECREED** that a person or  
14 an entity who asserts an interest in the defendant property must, pursuant to Fed. R. Civ.  
15 P. Supp. Rule G(5), file a verified claim, setting forth the person's or its interest in the  
16 property, that (a) identifies the specific property claimed, (b) identifies the claimant and  
17 states the claimant's interest in the property, and (c) is signed by the claimant under penalty  
18 of perjury pursuant to 28 U.S.C. § 1746;

19 **IT IS FURTHER ORDERED, ADJUDGED, AND DECREED** that the person  
20 or entity must file the verified claim with the Clerk of the above-entitled Court no later than  
21 35 days after the notice is sent or, if direct notice was not sent, no later than 60 days after  
22 the first day of publication on the official internet government forfeiture site,  
23 [www.forfeiture.gov](http://www.forfeiture.gov);

24 **IT IS FURTHER ORDERED, ADJUDGED, AND DECREED** that the person  
25 or entity must file an answer to the Amended Complaint for Forfeiture in Rem or a motion  
26 under Rule 12 with the Clerk of the Court, Lloyd D. George United States Courthouse,  
27 333 Las Vegas Boulevard South, Las Vegas, NV 89101, no later than 21 days after filing  
28 the verified claim;
