1 The Applicant, Securities and Exchange Commission ("Commission"), having filed an
2 Application for an Order to Show Cause and for an Order Compelling Compliance with
3 Administrative Subpoenas against Respondents Concept Capital Group, Inc., Concept Capital
4 Venture Fund LLC, Corporate Organizational Consultants, Inc., Luna & Vining APC and Luna
5 Law Group, the Court having considered the Application and documents filed in support thereof,
6 and good cause having been shown, the Court being fully advised in the matter, and there being
7 no just cause for delay:

8 IT IS HEREBY ORDERED that the Commission's Application for an Order to Show
9 Cause why an Order Compelling Compliance with Administrative Subpoenas should not be
10 issued is GRANTED.

21 Commission's reply papers, if any, be filed with this Court and served on Respondent or its
22 counsel, such that they arrive no later than 5:00 p.m. (PST) on February 25, 2013.
