**DEFENDANT’S MOTION TO EXCEED

 (DEFENDANT’S MOTION TO EXCEED
 PAGE LIMITATION FOR ITS MOTION
 FOR SUMMARY JUDGMENT)**

AND ORDER

18 Nextel of California, Inc. (hereinafter referred to as “Nextel” or “Defendant”) hereby
 19 moves the Court for an order permitting the filing of its Motion for Summary Judgment which
 20 exceeds the thirty page limit set forth in Local Rule 7-4.

21 The Court may allow briefs and motions in excess of this limitation when there is good
 22 cause. *See* LR 7-4. Defendant submits that there is good cause in this case. There are several
 23 communications that are addressed in the motion. There are also a number of important sections
 24 of deposition testimony. In both cases, for the convenience of the Court, Defendant has quoted
 25 those documents or lines of testimony, rather than requiring the Court to look through the record.
 26 Properly formatted quotations require a significant amount of space. As a result, In order to fully
 27 address all of these issues, Defendant’s Motion is approximately thirty-seven pages including the
 28

1 Table of Contents and Table of Authorities.

2 This request is made in good faith. Pursuant to Local Rule 7-4, a table of contents and a
3 table of authorities has also been prepared and is included in Defendant's Motion for Summary
4 Judgment. Accordingly, for the reasons set forth above, Defendant request that the Court grant its
5 request pursuant to LR 7-4.

6 Defendant also requests that its Motion to Exceed Page Limitations for its Motion for
7 Summary Judgment filed on December 5, 2013 (Dkt. #33) erroneously filed as an Ex Parte
8 Motion be withdrawn.


