17	court a settlement has been reached, and more than 30 days after the deadline to file the	
18	stipulation to dismiss or a status report indicating when it would be filed, the parties now state	
19	they will file a supplemental status report informing the court of their progress if a stipulation to	
20	dismiss is not filed. This case is more than 3 years old. The discovery cutoff expired July 11,	
21	2016. The deadline for filing dispositive motion	s expired August 9, 2016. The deadline for
22	filing the joint pretrial order is Sept 9, 2016. If	f the case has truly settled the stipulation to
23	dismiss is long overdue. If it has not and the parties are merely seeking to delay proceedings	
24	further efforts will be unsuccessful.	
25	IT IS ORDERED that the parties shall have until September 16, 2016, to file the	
26	stipulation to dismiss with prejudice if they have resolved their disputes. If not the parties shall	
27	file a joint pretrial order.
