16 **STIPULATION & PROPOSED ORDER OF DISMISSAL WITH PREJUDICE**

17 IT IS HEREBY STIPULATED by and between Defendant JOHN A. RITTER  
18 (“Defendant”), by and through his attorneys of record, the law firm of Reid Rubinstein &  
19 Bogatz, and Plaintiff, EDWARD KARAYAN, TRUSTEE OF THE KARAYAN FAMILY  
20 TRUST (“Plaintiff”), by and through his attorneys of record, the law firm of Richard L.  
21 Tobler, Ltd., as follows:

- 22 1. Defendant is the subject of an involuntary bankruptcy, jointly administered  
23 under U.S. Bankruptcy Court, District of Nevada, Case No. 16-10933-BTB (the  
24 “Bankruptcy”);  
25 2. Plaintiff has filed claims against Defendant in the Bankruptcy proceedings,  
26 which claims are representative of damages sought in this matter;  
27 3. Defendant has submitted a Chapter 11 Plan in the Bankruptcy (the “Plan”),

1 which has now been confirmed by the Bankruptcy Court and pursuant to which all claims  
2 against Defendant are discharged;

3 4. Based on the Plan being confirmed with Plaintiff being a creditor in said Plan,  
4 all claims filed against Defendant pursuant to the Bankruptcy must now be dismissed;

5 5. Accordingly, the status conference set for 3/19/2018 is vacated;

6 6. This Case is hereby dismissed with prejudice, provided, however, that this  
7 Case may be renewed in the event the discharge under the Plan is revoked in accordance with  
8 Section 14.4 of the Plan, with each Party bearing its own attorneys' fees and costs; and

9 7. This Case shall be closed.
