- 2 1) THE LAW OFFICE OF DAVID SAMPSON, LLC., receiving \$3,742.16 (\$3,000.00 in
3 fees and \$742.16 in costs) in satisfaction of the attorney lien; and
4 2) STEPHEN M. CARUSO, ESQ., receiving \$3,742.16 (\$3,000.00 in fees and \$742.16 in
5 costs) in satisfaction of the attorney lien; and
6 2) \$7,515.68, the balance of the funds, be paid to Medicare.
