MOTION TO SEAL RECORD

15 COME NOW, Plaintiffs, by and through their counsel of record, and submit this motion
 16 pursuant to Local Rule 7-5 and Fed. R. Civ. P. 5.2(a), to seal a certain record filed on July 24, 2013,
 17 more particularly described as Plaintiff’s Exhibits to Complaint (Dkt. 1-1). Said record contains
 18 information regarding the minor Plaintiff in this matter which is protected by Fed. R. Civ. P. 5.2(a).

20 This motion is made unopposed whereas this matter was opened yesterday; summons has
 21 not yet been issued, and no other party has yet been served or has otherwise appeared in this matter.

22 Upon opening of this case, the unredacted version of the intended exhibits were
 23 inadvertently filed as attachments to the Complaint (Dkt. 1). Upon discovery of this error, the
 24 undersigned counsel immediately contacted the federal court to report and to seek correction of the
 25 error. The undersigned received a return call this morning by court staff, who advised such filing
 26 error would require a motion, such as the instant motion, to correct the error by either sealing or

1 striking the record. Whereas a motion to strike such record would not prevent public access, a
2 motion to seal is necessary to protect the minor's information.

3 The appropriate redacted exhibits intended to be filed were filed as Amended Exhibits to
4 Complaint (Dkt. 3).

5 WHEREFORE, Plaintiffs moves the court for an order sealing Plaintiffs' Exhibits to
6 Complaints (Dkt. 1-1) filed herein.
