 20 Plaintiff LN Management LLC Series 5664 Divot and Defendant JPMorgan  
 21 Chase Bank, National Association (“Chase” and together with Plaintiff, the  
 22 “Parties”) stipulate to allow a 2-week enlargement of time to file a response to the  
 23 complaint as follows:

24 1. This is a quiet title action involving property at 5664 Divot Place, Las


