15	A Complaint for Forfeiture in Rem arising from a federal statute has been filed by the United
16	States of America ("United States") pursuant to Fed. R. Civ. P. Supp. Rule G. The Court, having
17	reviewed the Complaint, has found probable cause and that the United States has possession of the
18	defendant property; therefore, the clerk shall issue a Summons and Warrant of Arrest in Rem for the
19	Property, pursuant to Fed. R. Civ. P. Supp. Rule G(3)(b).
20	IT IS HEREBY ORDERED, ADJUDGED, AND DECREED that a Summons and Warrant
21	of Arrest in Rem for the Property issue against the \$257,497.93 in United States Currency
22	("property");
23	IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that the United States
24	seizes, arrests, attached, takes into custody, and retains property;
25	IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that notice of the action and
26	the arrest be given by the United States on the United States's official internet forfeiture site,

www.forfeiture.gov, for at least 30 consecutive days pursuant to Fed. R. Civ. P. Supp. Rule G(4)(a)(iv)
 which is reasonably calculated to notify potential claimants of this action;

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that a copy of the Complaint for Forfeiture In Rem, this Order, the Summons and Warrant of Arrest in Rem for the Property, and the Notice of Complaint for Forfeiture and Arrest be personally served or sent by certified mail, return receipt requested, and regular mail to any person who reasonably appears to be a potential claimant on facts known to the United States before the end of the 60 day publication period which is reasonably calculated to notify potential claimants of this action;

9 IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that the United States shall
10 file proof of publication and service with the Clerk of this Court;

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that a person or an entity
who asserts an interest in the defendant property must, pursuant to Fed. R. Civ. P. Supp. Rule G(5),
file a verified claim, setting forth the person's or its interest in the property, that (a) identifies the
specific interest in the property claimed, (b) identifies the claimant and states the claimant's interest in
the property, and (c) is signed by the claimant under penalty of perjury pursuant to 28 U.S.C. § 1746;

16 IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that the person or entity
17 must file the verified claim with the Clerk of the above-entitled Court no later than 35 days after the
18 notice is sent or, if direct notice was not sent, no later than 60 days after the first day of publication on
19 the official internet government forfeiture site, www.forfeiture.gov;

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that the person or entity
must file an answer to the Complaint for Forfeiture in Rem or a motion under Rule 12 with the Clerk
of the Court, Lloyd D. George United States Courthouse, 333 Las Vegas Boulevard South, Las Vegas,
NV 89101, no later than 21 days after filing the verified claim;

4IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that the person or entity5must serve a copy of the verified claim and the answer at the time of each filing on Michael A.
