**SPECIAL SCHEDULING ORDER
CONCERNING REVIEW OF
A SOCIAL SECURITY CASE**

This case involves judicial review of administrative action by the Commissioner of Social Security, denying Plaintiff’s claim for Social Security benefits. The Court recognizes that many of these cases have a number of factors in common:

1. Such cases rarely, if ever, require proceedings in the nature of a trial. Instead, these cases are usually resolved by cross-motions to reverse or remand and to affirm the Commissioner’s decision.
2. The transcript of the evidence adduced at the administrative hearing frequently contains the words, “inaudible” or “illegible” in some places, and the administrative record sometimes contains documents which are illegible. These parts of the administrative record may or may not relate to the question of whether the Commissioner’s decision is supported by substantial evidence.
3. These cases are automatically assigned to the United States Magistrate Judge for preparation of a Report and Recommendation to the United States District Judge.

THEREFORE, IT IS HEREBY ORDERED:

1. Defendant shall submit an electronic courtesy copy of the administrative record, under seal, to CM/ECF within **seven (7) days** of the filing of this Order. The courtesy copy shall be filed in a searchable PDF format with each exhibit linked separately and Optical Character Recognition performed.
2. In the event Plaintiff intends to request a remand of this case on the basis of new evidence, Plaintiff shall, within **thirty (30) days** of the filing of this Order, file a motion to remand in this Court based

1 on new evidence. The new evidence shall be attached to the motion. A copy of the motion and
2 evidence shall be served on:

7 3. In the event Plaintiff files a motion for remand on the basis of new evidence, the Defendant
8 shall have **thirty (30) days** from the date of service of such motion to file either (i) a notice of
9 voluntary remand of the case or (ii) points and authorities in opposition to Plaintiff's motion. If
10 Defendant files points and authorities in opposition, Plaintiff shall have **twenty (20) days** from
11 the date of service of such points and authorities to file a reply.

12 4. Under 42 U.S.C. § 405(g) remand for reconsideration of new evidence will not be granted
13 unless the evidence is new and material and there is a showing of good cause for failure to
14 incorporate the evidence into the record at an earlier stage. Therefore, if Plaintiff seeks remand
15 for consideration of new evidence, the motion shall include a statement of reasons why the new
16 evidence was not incorporated into the record at an earlier stage.

17 5. In the event Plaintiff does not file a motion for remand on the basis of new medical evidence,
18 the Plaintiff shall, within **thirty (30) days** of receipt of this Order, file with this Court a motion
19 for reversal and/or remand.

20 6. Whenever Plaintiff files a motion for reversal and/or remand, which includes issues based on
21 the administrative record, Plaintiff's motion shall include:

- 22 a. A specification of each and every condition or ailment, or combination of the two, that
23 allegedly renders Plaintiff disabled and is allegedly supported by evidence contained in
24 the administrative record.
- 25 b. A complete summary of all medical evidence in the record that supports Plaintiff's
26 claim of disability due to each condition or ailment with precise references to the
27 applicable portions of the record. The summary shall not include medical evidence
28 unrelated to the conditions or ailments upon which Plaintiff's claim or claims of
disability are based. It shall be sufficient compliance with this subparagraph if Plaintiff
stipulates that the Administrative Law Judge fairly and accurately summarized the

1 evidence contained in the record.

2 c. A complete summary of all other evidence adduced at the administrative hearing that
3 supports Plaintiff's claim with precise references to the applicable portions of the
4 record. It shall be sufficient compliance with this subparagraph if Plaintiff shall
5 stipulate that the Administrative Law Judge fairly and accurately summarized the
6 evidence adduced at the administrative hearing.

7 d. A complete but concise statement as to why the record does not contain substantial
8 evidence to support the Defendant's claim.

9 7. If Defendant has not filed a notice of voluntary remand and the issues in question relate to the
10 administrative record, the Defendant, within **thirty (30) days** after being served with Plaintiff's
11 motion for reversal and/or remand, shall file a cross-motion to affirm which will be considered
12 an opposition to Plaintiff's motion. This motion shall include:

13 a. A complete summary of all evidence in the record that the Defendant contends
14 constitutes substantial evidence to support the administrative determination that Plaintiff
15 is not entitled to the benefits in question. It shall be sufficient compliance with this
16 subparagraph if the Defendant stipulates that the Administrative Law Judge fairly and
17 accurately summarized the evidence contained in the record.

18 b. A complete summary of all testimony adduced at the administrative hearing, including
19 the Administrative Law Judge's findings, if any, concerning the credibility of witnesses,
20 which the Defendant contends constitutes substantial evidence to support the
21 administrative determination that Plaintiff is not entitled to the benefits in question. It
22 shall be sufficient compliance with this subparagraph if the Defendant stipulates that the
23 Administrative Law Judge fairly and accurately summarized the testimony adduced at
24 the administrative hearing.

25 c. A statement as to whether there are any inaccuracies in the summaries filed by Plaintiff.
26 If the Defendant believes Plaintiff's summaries are inaccurate, Defendant shall set forth
27 what additions or corrections are required (with appropriate references to the record) in
28 order to make the summaries accurate.

8. The motions filed by Plaintiff and Defendant pursuant to paragraphs 6 and 7 of this Order,

1 respectively, shall also contain appropriate points and authorities dealing with the specific legal
2 issues involved in this case, rather than principles of law applicable to Social Security cases in
3 general.

4 9. Plaintiff shall be deemed to have acceded to the accuracy of the summaries supplied by the
5 Defendant in response to subparagraphs 7(a) and 7(b) of this Order unless within **twenty (20)**
6 **days** after being served with Defendant's motion to affirm Plaintiff shall file and serve a reply
7 brief setting forth:

- 8 a. In what manner the summaries are inaccurate;
- 9 b. What additions or corrections are required (with appropriate references to the record) in
10 order to make the summaries accurate.


11 10. The motions filed by both Plaintiff and Defendant shall also contain the following:

- 12 a. A statement as to whether the transcript of the administrative hearing can be adequately
13 comprehended in spite of the fact that such transcript may contain the words "inaudible"
14 or "unintelligible" in one or more places, and specifying each page, if any, in which
15 testimony relating to the particular issues of this case cannot be adequately
16 comprehended.
- 17 b. A specification of each page in the administrative record that is partially or totally
18 illegible, and a statement whether each such illegible page contains information relevant
19 to an understanding of any issue presented in this case.

20 11. Oral argument shall be deemed waived and the case shall stand submitted unless argument is
21 ordered by the Court or requested pursuant to Local Rule 78-2, by one of the parties within **ten**
22 **(10) days** following the filing of the last document required by this Court. It shall be at the
23 Court's discretion whether oral argument is granted.

24 12. Failure of a party to file a motion or points and authorities required by this Order may result in
25 dismissal of the action or reversal of the decision of the Commissioner of Social Security.
