**ORDER DENYING MOTION FOR  
CONTEMPT SANCTIONS**

(Dkt. #131)

14 As part of an ongoing labor dispute, Teamsters has filed a motion for sanctions against  
15 Allegiant Air.<sup>1</sup> The motion primarily consists of allegations that Allegiant did not comply with  
16 the preliminary injunction I issued on July 22, 2014. According to Teamsters, Allegiant has  
17 “done nothing ‘to better respect pilot seniority’ in compliance with this Court’s order. And the  
18 result is that [Allegiant has] not provided basic ‘predictability’ as required by that same order.”<sup>2</sup>

19 On May 1, 2015, after a three-day evidentiary hearing in a related case, I issued an order  
20 holding that Allegiant had indeed complied with the July preliminary injunction.<sup>3</sup> Teamsters’  
21 motion for sanctions is therefore denied as moot to the extent that it tries to fault Allegiant for  
22 violating that injunction. The motion also contains references to misrepresentations Allegiant  
23 allegedly made to me before I issued the injunction.<sup>4</sup> I have set a hearing for later this summer to  
24 address those allegations. If Teamsters can prove at that hearing that Allegiant misled me, it can  
25 again move for contempt sanctions.
