R. Civ. P. Supp. Rule G(4)(a)(iv) which is reasonably calculated to notify potential claimants of this action;

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that a copy of the Complaint for Forfeiture In Rem, this Order, the Summons and Warrant of Arrest in Rem for the Property, and the Notice of Complaint for Forfeiture and Arrest be personally served or sent by certified mail, return receipt requested, and regular mail to any person who reasonably appears to be a potential claimant on facts known to the United States before the end of the 60 day publication period which is reasonably calculated to notify potential claimants of this action;

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that the United States shall file proof of publication and service with the Clerk of this Court;

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that a person or an entity who asserts an interest in the defendant property must, pursuant to Fed. R. Civ. P. Supp. Rule G(5), file a verified claim, setting forth the person's or its interest in the property, that (a) identifies the specific interest in the property claimed, (b) identifies the claimant and states the claimant's interest in the property, and (c) is signed by the claimant under penalty of perjury pursuant to 28 U.S.C. § 1746;

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that the person or entity must file the verified claim with the Clerk of the above-entitled Court no later than 35 days after the notice is sent or, if direct notice was not sent, no later than 60 days after the first day of publication on the official internet government forfeiture site, www.forfeiture.gov;

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that the person or entity

Supp. Rule G(5), (1) file a verified claim, setting forth the person's or its interest in the 5 property, that (a) identifies the specific interest in the property claimed, (b) identifies the claimant and 6 states the claimant's interest in the property, and (c) is signed by the claimant under penalty of perjury 7 pursuant to 28 U.S.C. § 1746; (2) file the verified claim with the Clerk of the above-entitled Court no 8 later than 35 days after the notice is sent or, if direct notice was not sent, no later than 60 days after the 9 first day of publication on the official internet government forfeiture site, www.forfeiture.gov; (3) file 10 an answer to the Complaint for Forfeiture in Rem or a motion under Rule 12 with the Clerk of the 11 Court, Lloyd D. George United States Courthouse, 333 Las Vegas Boulevard South, Las Vegas, NV 12 89101, no later than 21 days after filing the verified claim; and (4) serve a copy of the verified claim 13 and the answer at the time of each filing on Michael A. Humphreys, Assistant United States Attorney, 14 Lloyd D. George United States Courthouse, 333 Las Vegas Boulevard South, Suite 5000, Las Vegas, 15 Nevada 89101. 16

If a potential claimant fails to do so, a judgment of forfeiture by default will be entered against
that potential claimant for the relief demanded in the Complaint for Forfeiture in Rem.

All persons and entities who have an interest in the defendant property may, in addition to
filing a claim or in lieu of the filing of a claim, submit a Petition for Remission or Mitigation of the
forfeiture for a non-judicial determination of this action pursuant to 28 C.F.R. Part 9.
