21 Defendants James Cox, Brian Williams, Romeo Aranas, Francisco Sanchez, Frank
 22 Dreesen, Benedicto Guitierrez, Fred Richardson, and Cheryl Dressler, by and through
 23 counsel, Adam Paul Laxalt, Nevada Attorney General, and Jared M. Frost, Senior Deputy
 24 Attorney General, hereby move to extend the remaining discovery and scheduling
 25 deadlines for an additional thirty (30) days for settlement negotiation purposes.

1 a tentative agreement to settle the case.” *Id.* The parties further indicated that they “need
2 an additional thirty (30) days to finalize the agreement and wish to avoid any
3 unnecessary litigation costs that arise in connection with the Court’s upcoming case
4 management deadlines.” *Id.*

5 On August 11, 2016, the Court entered a minute order instructing the parties to
6 file settlement documents or a status report regarding the settlement in 30 days and
7 denying the stipulation to stay the case. ECF No. 92.

8 On August 12, 2016, Defendants filed a fourth motion to extend discovery and the
9 remaining scheduling deadlines for thirty (30) days for settlement purposes. ECF No. 93.

10 On August 15, 2016, Plaintiff filed a joinder to Defendants’ fourth motion to extend
11 the remaining deadlines. ECF No. 94. Plaintiff’s counsel also filed a motion to withdraw
12 from the case. ECF No. 93.

13 On August 19, 2016, the Court granted Defendants’ fourth motion to extend the
14 remaining deadlines. ECF No. 97.

15 On September 1, 2016, the Court held a hearing on Plaintiff counsel’s motion to
16 withdraw. ECF No. 98. Plaintiff did not appear at the hearing. *Id.* At the conclusion of the
17 hearing, the Court continued the hearing until September 19, 2016.

18 On September 12, 2016, Defendants filed an unopposed fifth motion to extend
19 discovery and the remaining scheduling deadlines. ECF No. 102. The Court granted
20 Defendants’ motion the following day. ECF No. 103.

21 On September 19, 2016, the Court held a hearing on Plaintiff counsel’s motion to
22 withdraw. ECF No. 104. At the hearing, counsel withdrew his motion, and the Court
23 directed the parties to file a status report as to settlement negotiations by September 23,
24 2016.

25 On September 23, 2016, the parties filed a joint status report informing the Court
26 that Defendants had provided Plaintiff with a draft settlement agreement on
27 September 19, 2016. ECF No. 105.

1 On September 28, 2016, the parties filed an amended joint status report indicating
2 they were working to resolve a Medicaid reimbursement issue needed to resolve the case
3 and that “[t]he execution of the settlement agreement should be finalized within the next
4 thirty (30) days following a final statement regarding Nevada Medicaid subrogation.”
5 ECF No. 106. The amended joint status report also indicated that Plaintiff’s counsel was
6 having some difficulty communicating with Plaintiff. *Id.*

7 On October 7, 2016, the undersigned spoke with Plaintiff’s counsel by phone.
8 Exhibit 1. Plaintiff’s counsel indicated that Plaintiff was still interested in settlement and
9 that he and Plaintiff were awaiting a statement to determine the amount of medical costs
10 Plaintiff may be required to pay Nevada Medicaid pursuant to the settlement agreement.
11 *Id.* In addition, Plaintiff’s counsel agreed that a further extension of the remaining
12 deadlines will likely be needed in this case. Later that day, the undersigned also spoke
13 with counsel’s assistant who confirmed that Plaintiff had requested a final statement
14 from Nevada Medicaid on August 28, 2016, and that Plaintiff was informed that the
15 statement would be provided within thirty days of the request. *Id.*

16 On October 12, 2016, Plaintiff’s counsel confirmed by phone that he did not oppose
17 Defendants’ motion for a sixth extension of the remaining scheduling deadlines. *Id.*

18 **II. APPLICABLE LAW**

19 Local Rule 26-4 (revised May 1, 2016) provides as follows:

20 A motion or stipulation to extend any date set by the discovery
21 plan, scheduling order, or other order must, in addition to
22 satisfying the requirements of LR IA 6-1, be supported by a
23 showing of good cause for the extension. A motion or stipulation
24 to extend a deadline set forth in a discovery plan must be
25 received by the court no later than 21 days before the
26 expiration of the subject deadline. A request made within 21
27 days of the subject deadline must be supported by a showing of
28 good cause. A request made after the expiration of the subject
deadline will not be granted unless the movant also
demonstrates that the failure to act was the result of excusable
neglect. A motion or stipulation to extend a discovery deadline
or to reopen discovery must include:

(a) A statement specifying the discovery completed;

1 (b) A specific description of the discovery that remains to be
2 completed;

3 (c) The reasons why the deadline was not satisfied or the
4 remaining discovery was not completed within the time limits
5 set by the discovery plan; and,

(d) A proposed schedule for completing all remaining discovery.

6 **III. ARGUMENT**

7 Defendants submit that there is good cause to extend the remaining discovery and
8 scheduling deadlines for an additional thirty (30) days. Defendants provide the following
9 information pursuant to Local Rule 26-4.

10 **A. Discovery Completed**

11 As of the filing of this motion, Defendants have provided Plaintiff with three sets of
12 production of documents pursuant to their disclosure obligations under Federal Rule of
13 Civil Procedure 26 and in response to Plaintiff's informal discovery requests. Plaintiff has
14 provided Defendants with two sets of production documents pursuant to his disclosure
15 obligations.

16 On February 9, 2016, Defendants took Plaintiff's deposition.

17 On February 25, 2016, Defendants served Plaintiff with requests for production of
18 documents. Defendants' requests included authorization forms to obtain an independent
19 set of Plaintiff's medical records.

20 On March 15, 2016, Plaintiff served Defendants with one set of interrogatories and
21 one set of requests for admissions for each of the following three Defendants: Brian
22 Williams, Romeo Aranas, and Benedicto Gutierrez.

23 On March 29, Plaintiff served Defendants with one set of interrogatories and one
24 set of requests for admission for Defendant Francisco Sanchez.

25 On April 7, 2016, Defendants served Plaintiff with responses to the interrogatories
26 and requests for admissions for Defendants Williams, Aranas, and Gutierrez.

1 On April 19, 2016, Defendants served their initial expert witness disclosures.¹

2 On April 22, 2016, Defendants served supplemental expert witness disclosures.

3 On May 3, 2016, Plaintiff provided Defendants with notarized copies of two record
4 release authorization forms.

5 On May 4, 2016, Plaintiff provided Defendants with responses to their requests for
6 production of documents.

7 On June 14, 2016, Defendants served Plaintiff with responses to the
8 interrogatories for Dr. Sanchez.

9 On July 11, 2016, Defendants served Plaintiff with two discs containing medical
10 imaging and copies of Plaintiff's medical records received from Plaintiff's third-party
11 medical providers. Defendants also served Plaintiff with one set of interrogatories.

12 **B. Discovery That Remains To Be Completed**

13 Plaintiff has not yet responded to Defendants' interrogatories.

14 Defendants have not yet served their expert reports.

15 **C. Reasons Why The Deadlines Were Not Satisfied**

16 On August 5, 2016, the parties reached a tentative agreement to settle the case as
17 indicated in their stipulation. *See* ECF No. 91. However, on August 11, 2016, Plaintiff
18 sent Defendants an email suggesting that he would not agree to settle unless Defendants
19 also paid Plaintiff's past and future medical expenses, a condition that could add tens of
20 thousands of dollars to the settlement figure Defendants had proposed. *See* ECF No.
21 102-1 (Declaration of counsel).

22 The parties have been working diligently to resolve Plaintiff's concern, ECF No.
23 106, and Plaintiff continues to express interest in Defendants' settlement offer, Exhibit 1.
24 However, Plaintiff has not yet received a final statement from Nevada Medicaid, *id.*, and
25 the parties therefore need an additional thirty (30) days to receive the statement and

27 ¹ Defendants did not provide Plaintiff with an expert report as part of their
28 disclosure. *See* ECF No. 72 (explaining that lack of disclosure was due to an oversight and
that additional time was needed to prepare the reports).

1 attempt to resolve the case through negotiation. Plaintiff does not oppose Defendants'
2 request to extend the remaining scheduling deadlines. *See id.*

3 **D. Proposed Schedule For Remaining Discovery And Scheduling**
4 **Deadlines**

5 Defendants propose the following remaining discovery and scheduling deadlines.

6 November 14, 2016 Close of discovery and last day to serve expert reports

7 December 12, 2016 Motions for summary judgment due

8 January 12, 2017 Joint pretrial order due (suspended until 30 days after
9 the Court resolves dispositive motions)

10 **IV. CONCLUSION**

11 There is good cause to extend the remaining discovery and scheduling deadlines for
12 an additional thirty (30) days and Defendants' unopposed request should be granted.
