**MOTION TO DISMISS PATRICIA
ARNOTT, STEPHANIE QUON AND
JESSICA QUON**

17 On December 15, 2015, Patricia Arnott, as trustee for the Nancy Quon Life Insurance
18 Trust dated February 10, 2005, Stephanie Lingle and Jessica Quon (the “Quons”) filed a motion
19 to intervene solely for the purposes of attending a settlement conference. (Dkt. 76.) The Quons
20 wished to appear because they are parties to *American General Life Insurance Co. v. Vistana*
21 *Condominium Owners Association*, case number 2:12-cv-01324-JAD-NJK, consolidated with
22 2:12-cv-01440-GMN-NJK. The issues being addressed in the settlement conference had
23 significant overlap with those in the *American General* case, and so intervening aided judicial
24 efficiency. The Quons’ motion was granted, and they appeared for the conference. (Dkts. 79;
25 81-82.)
