The Notice advised that if no action 16 is taken in this case by May 6, 2015, the Court will dismiss this action for want of prosecution. 17 18 Plaintiff has not complied within the allotted time period. 19 "Before dismissing the action, the district court is required to weigh several factors: (1) the public's interest in expeditious resolution of litigation; (2) the court's need to manage its 20 21 docket; (3) the risk of prejudice to the defendants; (4) the public policy favoring disposition of 22 cases on their merits; and (5) the availability of less drastic sanctions." Ghazali v. Moran, 46 F.3d 52, 53 (9th Cir. 1995) (internal citations and quotations omitted). All five factors point in 23 favor of dismissal. 24 25 Plaintiff has failed to show good cause why this action should not be dismissed without prejudice for want of prosecution pursuant to Local Rule 41-1. 26 27 /// 28 ///
