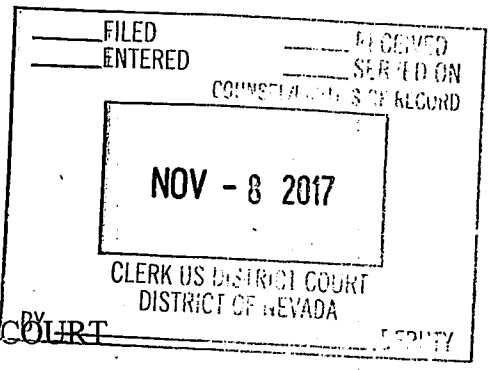

as follows:


**SUMMARY OF ARGUMENT**



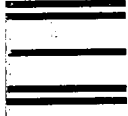

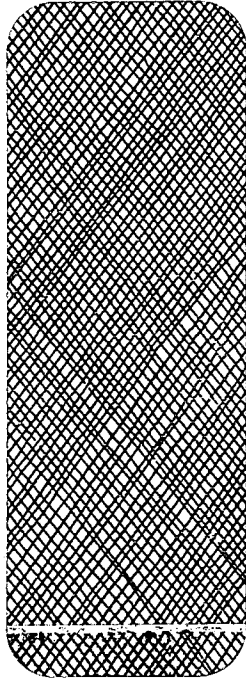
