**STIPULATION AND (PROPOSED)  
 ORDER TO CONTINUE HEARING  
 ON MOTION TO DISMISS FOR  
 LACK OF JURISDICTION**

**(FIRST REQUEST)**

 20 Defendant, Equity Title LLC (“Defendant”), by and through its counsel of record, Holley  
 21 Driggs Walch Fine Wray Puzey & Thompson, and Plaintiff, Shelley D. Krohn, Chapter 7 Trustee  
 22 (“Plaintiff”), by and through her counsel of record Diamond McCarthy LLP for good cause  
 23 shown, hereby stipulate and agree that the hearing on the Motion to Dismiss for Lack of  
 24 Jurisdiction, currently set for July 1, 2015, be continued to the first available Court hearing date  
 25 after July 23, 2015. This is the parties’ first request for an extension.

26 Defendant filed a Motion to Dismiss on May 22, 2014 (Dkt. No. 14).

27 Plaintiff filed her Response to Defendant’s Motion to Dismiss on June 9, 2014 (Dkt. No.  
 28 18).

1 Defendant filed its Reply to the Response to the Motion to Dismiss on June 17, 2014  
2 (Dkt. No. 20).

3 Plaintiff filed a Sur-Reply to Defendant's Motion to Dismiss on June 19, 2014 (Dkt No.  
4 22).

5 On July 24, 2015, the Court issued a Minute Order setting the hearing and oral argument  
6 on the Motion to Dismiss for July 1, 2015.

7 There exists good cause to grant this extension to hear the Motion for the following  
8 reasons:

9 1. An alleged conflict has arisen in this case and Defendant requires  
10 additional time before the hearing to resolve this conflict.

11 2. Plaintiff's counsel will be out of the country from July 4, 2015 through July 23,  
12 2015.

13 Therefore, Defendant and Plaintiff so stipulate that the hearing in on the Motion to  
14 Dismiss for Lack of Jurisdiction be continued to a date after July 23, 2015.
