17 Plaintiff Federal Trade Commission (“FTC”) and Defendants Crystal Ewing and Classic
18 Productions, LLC (collectively “The Parties”) hereby agree and stipulate as follows:

- 19 1. The Parties have agreed to a proposed settlement.
- 20 2. All settlements must be approved by the full Federal Trade Commission
21 (“Commission”).
- 22 3. The FTC filed its Motion for Summary Judgment (ECF #73) on July 1, 2015.
- 23 4. Defendants Ewing and Classic Productions’ Opposition is currently due on July
24 23, 2015.

1 5. Should the Commission reject the proposed settlement, the Parties agree that
2 Defendants Ewing and Classic Productions' Opposition to the FTC's Motion for Summary
3 Judgment shall be due 21 days after the Parties alert the Court that the Commission has rejected
4 the proposed settlement. The FTC would then have 14 days from the date of Defendants Ewing
5 and Classic Production's Opposition to file its Reply.
