9 **STIPULATION AND ORDER TO ALLOW ADDITIONAL TIME FOR PARTIES TO**
10 **MEET AND CONFER REGARDING FEES AND COSTS**

11 Plaintiff Cole Gustin, by and through his Guardians ad Litem Dorothy Kyle and
12 Joseph Kyle (“Plaintiff Cole Gustin”) and Defendant/Third-Party Plaintiff Dorskocil
13 Manufacturing Company (“Dorskocil” or “Defendant”) hereby enter into the following
14 stipulation upon which they request the Court enter an Order allowing additional time for
15 the parties to meet and confer regarding costs and fees. On August 27, 2015, this Court
16 heard oral argument on two of Dorskocil’s Motions to Compel (Doc #79, Doc #81)
17 (collectively the “Motions”). The Court ordered Carmen Gustin, guardian of Plaintiff Cole
18 Gustin, to pay costs and fees incurred for the IME with Dr. Lawrence Marshall Plaintiff
19 Cole Gustin missed on May 11, 2015. The Court ordered the parties to meet and confer
20 and, in the event that the parties could not agree, for Dorskocil to submit an application for
21 costs and fees within ten days. Since the hearing, counsel for Dorskocil attempted in
22 good faith to obtain itemized billings from Dr. Marshall to submit to Plaintiff Cole Gustin
23 for review. As of this date, Dr. Marshall advises that his office staff is continuing to
24 organize the billing documentation.

1 Based on the above representations, Plaintiff Cole Gustin and Daskocil agree to
2 allow an additional ten days for the parties to meet and confer regarding the costs and
3 fees associated with the missed IME, up to and including September 18, 2015. If the
4 parties cannot agree to a final amount by that date, Daskocil will file an application for
5 costs and fees.


