2 proceedings. As the Court is aware, the stay was put in place because many of the disputes at issue
3 in the Office of Dispute Resolution for Acquisition (“ODRA”) proceedings are relevant to the
4 present matter.

5 The ODRA hearing is scheduled to commence in February 2019. It is unlikely that
6 ODRA will issue a decision prior to May or June 2019. Whereas a telephonic status conference is
7 currently schedule for December 3, 2018, the parties request the status conference be vacated for
8 the convenience of the Court and the parties, and the Court continue the stay and reschedule the


