1 **STIPULATION AND ORDER TO EXTEND DEADLINE TO FILE PRETRIAL ORDER**
2 **(NINTH DISCOVERY DEADLINE REQUEST)**

3 Defendant Samuel R. Bailey (“Defendant”) by and through the law firm of Schwartz
4 Flansburg PLLC and Plaintiff Bank of America, N.A. (“Plaintiff”) by and through the law firm
5 of Holley Driggs Walch Fine Wray Puzey & Thompson (Defendant and Plaintiff collectively
6 “Parties”) hereby stipulate and agree to extend the deadline to file the Pretrial Order which is
7 currently due on October 21, 2017 as follows:

8 Based on the following, the Parties hereto respectfully request an extension to file the
9 Pretrial Order to be continued for 30 days, as follows:

- 10 1. The Parties stipulated to new deadlines on August 5, 2016 (ECF No. 64).
- 11 2. Thereafter, the Parties attended a Mediation at which some of the claims were
12 resolved.
- 13 3. Between Plaintiff/Counterdefendant BANA and Defendant/Counterclaimant
14 Bailey, the case was not resolved.
- 15 4. Following the Mediation, Defendant/Counterclaimant Bailey took the deposition
16 of the 30(b)(6) designee for Plaintiff/Counterdefendant BANA. The date for the 30(b)(6)
17 deposition had been set prior to Mediation and was set forth and contemplated in the
18 August 5, 2016 discovery stipulation (EFC No. 64).
- 19 5. Plaintiff/Counterdefendant BANA filed a Motion for Summary Judgment on
20 October 14, 2016 (ECF No. 68).
- 21 6. Defendant/Counterclaimant Bailey filed a Motion for Summary Judgment on
22 October 31, 2016 (ECF No. 70).
- 23 7. On June 22, 2017, the Court granted in part and denied in part
24 Plaintiff/Counterdefendant BANA’s Motion for Summary Judgment (ECF No. 76).
- 25 8. On June 22, 2017, the Court denied Defendant/Counterclaimant Bailey’s
26 Motion for Summary Judgment (ECF No. 76).
- 27 9. On July 19, 2017, BANA filed a Motion to Bifurcate Trial (ECF No. 77).
- 28 10. On August 2, 2017 Bailey filed a Response to Motion to Bifurcate Trial (ECF No.

1 80).

2 11. On August 18, 2017, BANA filed a Reply to its Motion to Bifurcate Trial (ECF
3 No. 84).

4 12. On August 18, 2017, the Court granted a Stipulation to Extend Time to Reply to
5 Motion to Bifurcate (ECF No. 85).

6 13. On September 21, 2017, the Court denied the Motion to Bifurcate Trial (ECF No.
7 88).

8 14. The parties desire a final opportunity to discuss settlement and potentially
9 schedule a mediation.

10 **LR26-4 Statement:**

11 Good cause and/or excusable neglect exist to extend Pretrial Order deadline for the
12 express purpose of exploring a renewed mediation and settlement negotiations between the
13 Parties.

14 The current deadline to file the Pretrial Order is October 21, 2017 and the Parties request
15 that the deadline to file the Pretrial Order be continued for 30 days.




ORDER


