- 22 1. The Complaint was filed on August 1, 2014 (Doc. No. 1);
- 23 2. A First Amended Complaint was filed on November 21, 2014 (Doc. No. 13);
- 24 3. Defendant Atlas Copco U.S.A. Holdings, Inc. was served with the First Amended
 25 Complaint on December 18, 2014 (Doc. No. 17);
- 26 4. Defendant Mining, Rock Excavation and Construction, LLC was served with the
 27 First Amended Complaint on December 22, 2014 (Doc. No. 18);
- 28 5. Plaintiff was served with Defendants’ Motion to Dismiss on January 20, 2015 (Doc.

1 No. 21);

2 6. The parties stipulated extending the time for Plaintiff to oppose Defendants' Motion
3 to Dismiss to February 19, 2015 (Doc. No. 25);

4 7. Plaintiff filed its Opposition to Defendants' Motion to Dismiss on February 19, 2015
5 (Doc. No. 26);

6 8. Due to the general press of business, Defendants requested and Plaintiff agreed to
7 a one-week extension for Defendants to submit a reply in support of Defendants' Motion to
8 Dismiss;

9 9. Therefore, good cause exists to extend the date for Defendants Atlas Copco
10 U.S.A. Holdings, Inc. and Mining, Rock Excavation and Construction, LLC to submit a reply in
