AMENDED JUDGMENT


22 On March 30, 2016, Judgment [ECF No. 61] was entered in favor of Defendants Nye
23 County Deputy Sheriff Mark Murphy ("Deputy Murphy"), and Nye County Deputy Sheriff
24 Crystal Barajas ("Deputy Barajas") (collectively "Defendants"), and against Plaintiff Samuel
25 Jones. On March 5, 2016, the Court awarded Defendants their cost in the amount of \$11,319.43
26 [ECF No. 63]. On December 27, 2016, the Court awarded Defendants their attorney's fees in the
