19 Pursuant to LR 6-1, 6-2 and 7-1 and 26-4, at Plaintiff’s request, Plaintiff Fabian Villarreal
 20 (“Plaintiff”) and Defendants Eldorado Resorts Corporation (“Eldorado”), Michael Marrs
 21 (“Marrs”), Kristen Beck (“Beck”), and Dominic Taleghani (“Taleghani”) (sometimes hereinafter
 22 referred to collectively as “Defendants”) by and through their undersigned counsel, hereby
 23 stipulate and agree to extend the time for Plaintiff to file Plaintiff’s Response to Defendants’

1 Response and Defendants' Reply related to Defendants' Motion for Summary Judgment.
