19 **STIPULATION AND PROPOSED ORDER**

20 Pursuant to Local Rules 6-1 and 26-4, the parties, by and through their respective attorneys of
 21 record, stipulate and agree to extend the deadline to file the Joint Pre-Trial Order by an additional sixty
 22 (60) days.

24 The Court previously ordered the Joint Pre-Trial Order to be filed within thirty (30) days
