 20 **STIPULATION AND PROPOSED ORDER**

21 Pursuant to Local Rules 6-1 and 26-4, the parties, by and through their respective attorneys of
 22 record, stipulate and agree to extend the deadline to file the Joint Pre-Trial Order by an additional
 23 sixteen (16) days.

24 The Court previously ordered the Joint Pre-Trial Order to be filed within thirty (30) days
 25 following its ruling on final dispositive motions. On September 29, 2017, the Court issued its ruling on
 26 the parties' respective dispositive motions. [Doc. No. 154], thereby making the Joint Pre-Trial Order due
 27 on or before October 31, 2017.

28 On December 14, 2017, this Court approved a Stipulation between the parties to extend the time

1 to file the Joint Pre-Trial Order until January 15, 2018. [Doc. No. 158] The parties have a working draft
2 and anticipate finalizing the Order by January 31, 2018. Accordingly, the parties have agreed and
3 stipulated to the following deadline:

4 Final Joint Pre Trial Order to be filed by: **January 31, 2018.**


