The Court previously ordered the Joint Pre-Trial Order to be filed within thirty (30) days following its ruling on final dispositive motions. On September 29, 2017, the Court issued its ruling on the parties' respective dispositive motions. [Doc. No. 154], thereby making the Joint Pre-Trial Order due on or before October 31, 2017.

On December 14, 2017, this Court approved a Stipulation between the parties to extend the time

to file the Joint Pre-Trial Order until January 15, 2018. [Doc. No. 158] On January 31, 2018, Defendants 1 2 filed a Motion to Extend the Time to File the Joint Pre-Trial Order. [Doc. No. 161]. That same day, 3 Plaintiff's Counsel Todd Terry, Esq., agreed by electronic mail to the one week extension sought in the 4 Motion. On January 31, 2018, the Court granted the Motion by Minute Order, moving the deadline to 5 **February 7, 2018.** [Doc. No. 162]. Since that time, the parties have been engaged in substantive 6 settlement negotiations to resolve this matter in its entirety.
