17 Plaintiff, Federal Deposit Insurance Corporation as Receiver of Washington Mutual Bank
18 (“FDIC-R”) and Defendant, Nevada Title Company (“Nevada Title”) (collectively the “Parties”), by
19 and through their respective counsel, hereby stipulate pursuant to LR 7-1 to extend the deadline for
20 FDIC-R to file a response to Nevada Title's motion for summary judgment [ECF No. 42], filed on
21 August 19, 2016, up to and including September 26, 2016; and to extend the deadline for Nevada
