16 IT IS HEREBY STIPULATED AND AGREED by the parties' counsel of
17 record that the parties will have an extension of time up to and including January 10,
18 2017 to file a Joint Pretrial Order in this case. This is the second request for an
19 extension of this deadline since the Court issued its Order relating to summary
20 judgment on September 23 (ECF No. 91).

22 Because of the possibility of settlement, the parties did not work on a Joint
23 Pretrial Order until after the November 17, 2016 Settlement Conference. Thereafter,
24 Plaintiff's counsel have been involved with a trial in another matter, and defense
25 counsel currently faces the prospect of a trial occurring sometime during the course of a
26 five-week stacked calendar starting on January 17, 2017. Defense counsel also
27 presently has a Joint Pretrial Order due on December 30 in a case involving close to

1 20,000 pages of documents. This is in addition to the holidays and the various other
2 deadlines and commitments that both counsel have in other matters. The foregoing
3 constitutes good cause for the extension of the deadline.
