27 IT IS ORDERED that Emergency Motion to Withdraw as Counsel of Record for Plaintiff

1 IT IS FURTHER ORDERED that Plaintiff Blair Mielke will have until Wednesday, July
2 22, 2015, to retain new counsel, who must file a notice of appearance in accordance with the
3 Local Rules of Practice, or to file a notice to proceed Pro Se.

4 IT IS FURTHER ORDERED that all remaining discovery deadlines are extended for
5 three (3) weeks, as follows:
