1 On February 27, 2015, Plaintiff served on Defendant his Expert Disclosures Pursuant to
2 Fed. R. Civ. P. 26(a)(2)(B), and Notice of Deposition of Defendant's Person Most
3 Knowledgeable on April 8, 2015.

4
5 On March 5, 2015, Defendant served on Plaintiff its Initial Disclosures Pursuant to Fed.
6 R. Civ. P. 26.1.

7 On March 9, 2015, Plaintiff served on Defendant his Second Set of Interrogatories
8 Pursuant to Fed. R. Civ. P. 33 and Second Set of Requests for Production of Documents Pursuant
9 to Fed. R. Civ. P. 34
10

11 On March 16, 2015, Defendant served on Plaintiff its Responses to Plaintiff's First Set of
12 Requests for Admission Pursuant to Fed. R. Civ. P. 36, First Set of Requests for Production of
13 Documents Pursuant to Fed. R. Civ. P. 34, and First Set of Interrogatories Pursuant to Fed. R.
14 Civ. P. 33.

15
16 On March 17, 2015, Plaintiff served on Defendant his First Amended Notice of
17 Deposition of Defendant's Person Most Knowledgeable on April 8, 2015.

18 On March 18, 2015, Plaintiff served on Defendant his First Supplemental Disclosures
19 Pursuant to Fed. R. Civ. P. 26.1.

5 Deposition and Subpoena to Testify at a Deposition in a Civil Action on May 14, 2015 of non-
6 party Manfred Birnbaum, his First Amended Notice of Deposition and Subpoena to Testify at a
7 Deposition in a Civil Action on May 22, 2015 of non-party Irwin Gross, his First Amended
8 Notice of Deposition and Subpoena to Testify at a Deposition in a Civil Action on June 3, 2015
9 of non-party Mark Dacko, and his First Amended Notice of Deposition and Subpoena to Testify
10 at a Deposition in a Civil Action on June 4, 2015 of the Person Most Knowledgeable of Maslon
11 LLP.
12

13 On April 10, 2015, Defendant served on Plaintiff its First Supplemental Disclosures
14 Pursuant to Fed. R. Civ. P. 26.1, its First Set of Requests for Admissions Pursuant to Fed. R. Civ.
15 P. 36, and its First Set of Requests for Production of Documents Pursuant to Fed. R. Civ. P. 34,

5 Sanctions and Motion to Extend the Time for Depositions, See Doc. 25, dated April 28, 2015,
6 Defendant served on Plaintiff its Second Supplemental Response to Plaintiff's First Set of
7 Interrogatories No. 1, 2, 3, 4, 5, 6, 7, 8, 10, 11, 12 and 13, its Second Supplemental Responses to
8 Plaintiff's First Set of Requests for Production of Documents, and its Second Supplemental
9 Responses to Plaintiff's First Set of Requests for Admission No. 1, 2, 4, 5 and 6. Defendant also
10 served on Plaintiff its Third Supplemental Disclosures Pursuant to Fed. R. Civ. P. 26.1, its

16 On June 3, 2015, Plaintiff served on Defendant his Fourth Amended Notice of Deposition
17 (To Be Taken by Telephone At Deposition Location) and Subpoena to Testify at a Deposition in
18 a Civil Action on August 20, 2015 of non-party Manfred Birnbaum. **THE FOURTH**
19 **AMENDED NOTICE OF DEPOSITION IS THE SAME AS THE THIRD.**

21 On June 10, 2015, Defendant, in accordance with the “meet and confer” telephone
22 conference between Plaintiff’s counsel and Defendant’s counsel, served on Plaintiff its Third
23 Supplemental Responses to Plaintiff’s First Set of Interrogatories Number 2.
24

25 On June 12, 2015, Defendant served on Plaintiff its Third Set of Requests for Production
26 of Documents Pursuant to Fed. R. Civ. P. 34.
27

28 On June 17, 2015, Plaintiff served on Defendant his Third Amended Notice of
Deposition and Subpoena to Testify at a Deposition in a Civil Action on September 2, 2015 of

1 non-party Mark Dacko and his Fourth Amended Notice of Deposition and Subpoena to Testify at
2 a Deposition in a Civil Action on September 3, 2015 of the Person Most Knowledgeable of
3 Maslon LLP.

4
5 On June 15, 2015, Defendant's counsel sent correspondence to Plaintiff's counsel
6 addressing Defendant's substantive concerns regarding Plaintiff's discovery responses and
7 objections prior to the scheduled "meet and confer" to discuss Defendant's issues.

8 On June 18, 2015, Defendant served on Plaintiff's counsel its Third Amended Notice of
9 Deposition of Plaintiff on August 17, 2015.

10
11 On June 22, 2015, Plaintiff served on Defendant his Fourth Amended Notice of
12 Deposition of Defendant's Person Most Knowledgeable on July 17, 2015.

13 On June 23, 2015, Plaintiff served on Defendant his Notice of Cancellation of the
14 Deposition of non-party Irwin Gross which had been scheduled for June 29, 2015.

15
16 On June 23, 2015, Plaintiff's counsel filed an Emergency Motion to Withdraw as
17 Attorney for Plaintiff. See Doc. 42. The Court granted Plaintiff's Motion on July 6, 2015. See
18 Doc. 51.

19 Plaintiff subsequently retained local counsel who filed his Notice of Appearance on July
20 22, 2015. See Doc. 52. However, Plaintiff also retained other counsel whose Verified Petition for
21 Permission to Practice Pro Hac Vice and Approving Designation of Local Counsel, filed on
22 August 28, 2015 (See Doc. 54), was not granted until September 8, 2015. See Doc. 56.

23
24 As such, Parties' counsel have not been able to timely resolve Defendant's substantive
25 issues with Plaintiff's discovery responses and reschedule and conduct previously notice
26 depositions.
27
28

1 As the Parties' counsel, in spite of their best efforts and due diligence, have been unable
2 to effect the necessary discovery, there exists good cause for their requested extension of time.

3 Pursuant to the Parties' Joint Interim Status Report, See Doc. 53, the Parties are available
4 for trial on January 11 through January 13, 2016, January 18 through January 20, 2016, or
5 January 25 through January 27, 2016, and so the requested extension of time will not affect the
6 trial of this action.
