4 is needed to receive and review the deposition transcript and incorporate it into the briefing. The
5 parties believe that the additional time will be sufficient for both parties to properly brief their
6 positions. This request is made in good faith and not for the purposes of delay.

8 The parties agree to extend the time for Defendants to file the opposition to **January 18, 2018**.

9 The parties agree to extend the time for Plaintiff to file her reply to **February 8, 2018**.
