**Order**

[ECF Nos. 66, 68, 70, 71, 76]

10 Section 2254 petitioner Benny Hammons moves for an extension of time to file his reply to  
11 respondents' answer and respondents have filed two motions for partial waiver of this court's local  
12 rules and to seal an exhibit to their answer. I grant Hammons's request for an extension and  
13 respondents' motions.

14 Respondents seek leave to file an answer in excess of the page limit and a waiver of Local  
15 Rules IA 10-3(e), which requires the cover page of each filed exhibit to include a description of the  
16 exhibit,<sup>1</sup> representing that adding descriptors to the cover pages of 130 exhibits in this action is  
17 unduly burdensome. Because of the large number of exhibits in this case, I waive Local Rule IA 10-  
18 3(e)'s cover-page requirement for both parties.

19 Respondents also seek a waiver of LR 10-3(i), which requires paper courtesy copies of  
20 exhibits exceeding 100 pages. Because respondents have already filed about 120 of the exhibits in  
21 this case and there are only approximately ten exhibits that respondents filed in support of their  
22 answer, I grant respondents' request. Because of the size of the record in this case, I also find good  
23 cause to grant respondents' motion to file an answer in excess of 24 pages.<sup>2</sup>


1 **Conclusion**

2 Accordingly, IT IS HEREBY ORDERED that Hammons's motion for order to show cause  
3 why respondents did not file an answer [ECF No. 66] is **DENIED** as moot.

4 IT IS FURTHER ORDERED that respondents' motions for partial waiver of local rules  
5 [ECF Nos. 68, 70] are **GRANTED** consistent with this order.

6 IT IS FURTHER ORDERED that respondents' motion to seal exhibits [ECF No. 71] is  
7 **GRANTED**, and Hammons's motion for extension of time to file his reply to the answer [ECF No.  
8 75] is **GRANTED**. **Hammons's reply is due by March 10, 2017.**
